Qatar Exchange hereby informs you as follows:

QE Index

Following the semi-annual review of QE Index constituents, effective April 1st 2012 Salam and Al Khalij Holding will be removed from the 20 stock index and Al Meera and Qatar Meat and Livestock will become constituents.

A reminder that effective April 1st QE implements a methodology change for QE index whereby the maximum weight a single stock can hold within QE index as of the rebalance date is 15%. If during the index review any stock is found to exceed this weight, then the stock's market value is capped and any excess weight is distributed proportionately among the remaining index constituents. This rule also applies to the new QE Total Return index, constituents of which are identical to the QE Index.

Indicative weightings for the QE index as of April 1st are shown below. This is based on March 15th closing prices and free float figures and is subject to change (due to corporate actions) between now and April 1st. QE will notify of final share figures following close of business March 29th.
